In 2021 the ESCO Technologies Foundation gave \$410,698 in grants in support of charitable organizations, scholarships, and employee hardship cases. Throughout 2020-2021, as the impacts of the pandemic continued to be felt throughout our local communities, we were able to give \$165,000 in COVID-19 relief funds grants. These grants were in addition to our recurring annual giving programs, and were primarily focused on organizations distributing food and other necessities. As a result it was the second consecutive year in which we gave more in grants than we received in donations. Moving forward our plan will be to return to a more balanced budget, but it has been reassuring to have had the flexibility to give more during this time of great need in our local communities.

## Mayday & Hi-Tech

MHMR Center

This year Mayday/Hi-Tech partnered with the Denton County MHMR Center and supported their Holiday Helping Hands program. Denton County MHMR Center provides support for individuals with mental health issues or a developmental disability diagnosis and their families. They provide a crisis hotline, clinical assessments, and outpatient and residential treatment services. As a company we committed to providing gifts to brighten the lives of 24 people this holiday season, with their needs identified on angel cards.



Mayday/Hi-Tech employees also collected donations for the Denton Animal Shelter. Community support of DASF helps make pet ownership more affordable, reduces pet abandonment and overpopulation, and provides emergency food assistance.

**LIFT FOR LIFE ACADEMY**  
Educate Empower Uplift

ESCO employees supported Lift for Life Academy (LFLA) this holiday season. LFLA is a charter school in the city of St. Louis. They began in 2000 as a middle school and now serve 825 K-12 students. Families choose LFLA as a creative and motivating alternative to the St. Louis public schools. LFLA prides itself on its ability to reach and engage their students through a safe, compassionate and structured setting. They have a 97% high school graduation rate and 80% of last year's high school graduating class was accepted into college, technical schools, or the military. Employees donated \$1,015 and the Foundation contributed an additional \$1,000. Our donations are being utilized to purchase books for their K-4<sup>th</sup> grade library.

## Community Service

### *Globe Composite Solutions*



Globe employees participated in a Spin-A-Thon fundraiser in support of the Old Colony YMCA in Stoughton. Each year hundreds of members, volunteers, and Y supporters gather to cycle on stationary bikes and raise money to support those in need in their local community. Throughout the pandemic, the Old Colony Y has been helping children and families most at-risk by delivering food and basic goods every day. Since March 2020, they have provided more than 200,000 meals to families throughout southeastern Massachusetts. They also provide shelter to families experiencing homelessness and offer mental health counseling. The event raised \$75,200.



### *Mayday/Hi-Tech*

Mayday/Hi-Tech utilizes machinery that cuts circles out of sheets of cardboard. The sheets are utilized in their production process, but the circles are trash. The circles are boxed up and donated to local schools, churches, and daycares. The picture below shows a local elementary school project utilizing the donated cardboard circles.



### *PTI*

PTI recently hosted a “grab and go” appreciation lunch for the Oxnard Police Department. They served 125 boxed lunches as a thank you for their dedication in serving the community.



## ***2022 Scholarship Program***

Information and applications for the 2022 ESCO Technologies Foundation Scholarship program were recently distributed. Children and stepchildren of full or part-time U.S. employees of ESCO Technologies and its domestic subsidiaries are eligible to apply.

The applications are divided into two pools:

- Pool 1 - for students attending four-year colleges/universities or pursuing postgraduate studies
- Pool 2 - for students at Community or Junior Colleges and Trade, Vocational or Technical schools.

All scholarship applications must be submitted by April 30, 2022 via email to [scholarship@escotechnologies.com](mailto:scholarship@escotechnologies.com). An email will be sent to each applicant confirming receipt of their application. If for any reason the applicant does not receive a confirmation email, they should contact Kate Lowrey at 314-213-7243.

The announcement of scholarship awards will be made in June. One in four applicants from each pool will receive a one-time \$3,000 scholarship. Since program inception, 148 scholarships totaling \$429,250 have been awarded.

Selection criteria and program specifics are provided in the “2022 Scholarship Announcement, Guidelines and Application” that was recently distributed electronically and is also available from your local board member or HR department.

Applicants may only win one time. While prior scholarship recipients may not participate, past applicants who have not yet been awarded a scholarship are encouraged to apply again. All applicants will receive a backpack to utilize for the upcoming year.
