The Foundation provides support to our communities and employees in a variety of ways. In 2024, we are on track to give over \$400,000 in core charity, scholarship, employee hardship and miscellaneous giving grants.

Our core charities grants are made annually and are intended to be large enough to make a meaningful difference to these charitable organizations and our respective communities. To date the Foundation has given over \$4.2 million to our core charities.

Through our miscellaneous giving program, we are able to make smaller grants to support charitable organizations where our employees have a personal connection. These donations are intended to support our employees who volunteer or participate in fundraising runs or walks. They can also be given along with subsidiary volunteer events or holiday giving campaigns. To date we have given over \$200,000 in miscellaneous giving grants.

The ESCO Technologies Foundation has been supporting Habitat for Humanity Lake County since 2014 and recently made the organization one of our core charities. Each year the ETS-Lindgren Wood Dale office partners with Habitat on a construction site, helping build a house for a family in need. After a day filled with hard work, our employees are able to see how their labor pays off in helping the family that will eventually call that house their home.

Dustin Goffron, a Principal Project Engineer at ETS-Lindgren, has personally been involved with Habitat for Humanity Lake County since 2009. He began as a volunteer on construction sites and along with many other Wood Dale employees, has helped build numerous homes over the years. In 2016, Dustin joined the board of directors and in 2022 he was elected Vice President of the board. He is also currently the head of the Development Committee at Habitat where they work on fundraising and partnership opportunities.

Crissair – Core Charity



The Painted Turtle provides a life changing environment and authentic camp experience for children with chronic and life-threatening illnesses. The organization inspires these children to reach beyond their illnesses, and provides care, education, and respite for their families. They have provided more than 180,000 transformative Camp experiences to children with serious illness and their families - all completely free of charge.

In 2023, The Painted Turtle returned to a full year of on-site sessions at 80% capacity, while their Hospital Outpost team delivered the magic of Camp to thousands of children and caregivers at 21 hospitals across the state. Fueled by a bold new three-year Strategic Plan aimed at serving as many children with serious illnesses and their families as possible, they provided over 43,000 Camp experiences in 2023, the highest number since they opened two decades ago!

In 2024, Crissair employees volunteered at their Aerospace Volunteer Day and the Foundation provided a \$10,000 core charity grant. The Painted Turtle has expressed how grateful they are for our ongoing commitment to serving their campers over the last five years.
